RESOLUTION AWARDING A COMPETITIVE CONTRACT FOR PROVIDING CATERING SERVICES FOR THE OFFICE ON AGING DEPARTMENT IN SALEM COUNTY

WHEREAS, the Salem County Purchasing Agent, as authorized Contracting Agent for the Board of County Commissioners of the County of Salem requested, received, and opened sealed proposals on December 5, 2025, at 11:00 AM prevailing time for Providing Catering Services for the Office on Aging Department in Salem County; and

WHEREAS, N.J.S.A. 40A:11-4.1(g) provides that a local contracting unit may use competitive contracting in lieu of public bidding for procurement of specialized goods and services, the price of which exceeds the bid threshold, for certain purposes including the aforementioned; and

WHEREAS, proposals were received as follows:

WHEREAS, all RFP results and recommendations for contract award are on file in the office of the Purchasing Agent, 110 Fifth Street, Suite 400, in the County of Salem New Jersey as required by law; and

WHEREAS, it has been determined that the company, Isidra Maya LLC, substantially met the necessary qualifications for the fulfillment of this contract, and further provided the documentation necessary to successfully fulfill the requirements of the Office on Aging Department in Salem County; and


WHEREAS, as allowable pursuant to N.J.S.A. 40A:11-4.1(g) the period of this competitive contract shall be for a one (1) year period commencing on January 1, 2026, and terminating on December 31, 2026 with two (2) one-year renewal options which may be exercised upon joint agreement by the County and the vendors.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem as follows:

1. The Salem County Board of County Commissioners hereby awards a contract to provide Catering Services for the Office on Aging Department in Salem County, subject to the review of the County Solicitor, to Isidra Maya LLC, 449 E. Broadway, Salem, NJ 08079 the cost of which will not exceed \$32,265.00 (Thirty-Two Thousand Two Hundred Sixty-Five Dollars and Zero Cents).
2. The Commissioner Director and the Clerk of the Board shall be authorized to execute said contracts upon compliance by the firm with all requirements and specifications.
3. The contract shall commence on January 1, 2026, and food services will continue through December 31, 2026 with two (2) one-year renewal options. This shall be completed in full accordance with the terms and conditions of the contract.

4. This contract is made contingent upon receipt and appropriation of sufficient grant funds in the 2026 budget.
